1. There are seven OBHUNT standby agents.
Ruslat PLAKU
2. RNDOLLAR is now living in Menidhi with his wife. He was contacted by [] and [] several times this past month. His processing for emigration is progressing and it is expected he and his wife will be leaving Greece in the near future.
3. AIRWISE was contacted at regular intervals in this past month. On 28 April he was passed his monthly pay and the regular Easter Bonus paid to our indigenous employees— *in Athens*.
Skander BLACH POB Albania
4. RNORDAIN and AIRBORNE are still living together on the outskirts of Athens. They continue to contact the office by telephone and are met regularly by [] or []. They were last contacted on 28 April when they were paid and given their bonus.
Lagron SELENICA
5. AIRBLOWN and AICCOOL are living in a hotel in Pireaus. They have been there for about a year. [] was instructed them to locate new quarters as their cover story has been worn thin. Both men have started a new course at the Benchfitters School. AIRBLOWN's resettlement processing is now in the advanced stages and he will be departing for the U.S. shortly.
Lorenz KALLA Banki SEIT
6. AIPUMP and AILICH were called into Athens from Khalkis on 26 April as AIPUMP was scheduled to leave on a special flight for the United States on 30 April. On 27 April both AILICH and AIPUMP were met by [] and []. AIPUMP signed the necessary termination papers and was given his separation pay. Details of his termination will be reported in a separate dispatch. AILICH was paid his monthly salary and Easter Bonus and given permission to remain in Athens until AIPUMP had departed.
