2. AICOOL was terminated by AUSBON on 9 July. His Agent Service Record and signed Quitclaim and Secrecy Agreement were forwarded to Headquarters with reference B. It is expected AICOOL will depart Greece in September for resettlement in the United States.

3. RNDOLLAR, with his wife, has completed his processing and only awaits the issuance of a visa to prepare him for his departure to the United States. He was met several times by [] during this period and was last contacted on 30 July.

4. AIRWISE also had his processing for emigration expedited and it is expected he will be leaving Greece in about two months. He continues to suffer from the same stomach disorder that has plagued him in the past. He visits a doctor regularly but the exact ailment has never been determined.

5. AILICH was married on 14 July and is now living in Menidhi with his wife. Efforts are being made to process his wife for emigration to permit their leaving Greece together. The visa-consul has reserved a visa number for Mrs. AILICH and if processing can be completed in time, they may be able to leave together.

6. AIRBLOWN is still living in Pireaus and attending the Benchfitters' Course. AIRBLOWN'S processing unfortunately is slow due to his residence in several countries (England, Italy, and Germany) besides Greece.

7. RNORDAIN and AIRBORNE have both had their preliminary processing completed but continue in a "hold category" as long as we desire. Because of their ability and experience in cross-border operations, we are keeping these two agents in reserve to maintain our capability to capitalize on an opportunity and continue our franchise in cross-border operations. Both men are contacted regularly by [] and [] and every effort is made to keep alive their interest in operations. This is difficult in view of their long inactivity.
