1. The primary purpose of this trip to HTStein was to discuss with [] the disposal problem of some 29 HTFlower agents now on hand. These include the 7 famous rejects now held by the LCFlakes for us in the Identity (1), 10 which were sent here on the 10th of October from HTStein due to the misunderstanding caused by a priority cable (MUNI 5301) requiring six days to arrive here from HTStein, 4 exfiltrated members of Cypress team, 2 Chestnut team exfiltrates, plus 4 W/T washouts and 2 operational washouts; the latter 10 are presently held at Wangness. [] agreed to bring up at once with DTElder the question of returning these men to the HParson. Inasmuch as our agent-recruiting pipeline has been blown due to the Lyceum trials and taking into consideration the fact that no further agent-recruiting will be done in the future from HParson, the question of HParson security as originally proposed to DTElder is no longer effective. BGFiend is presently awaiting word from DTElder on their decision.

2. The status of Fiend personnel in HTStein was then discussed. [] agreed that it was desirable that the HTFlower-speaking training staff remain under Fiend's jurisdiction for use as training, conducting and dispatching officers. [] remains directly responsible to the HTStein station for administrative purposes, although he continues under [] for directives in such as they affect BGFiend operations. [] desires to send [] and possibly [] to the ZASedan BGHives school at (2) during the winter months and requested [] to make the necessary arrangements. [] and [] will be assigned to [] training staff during the winter season. Arrangements were made with Communications chief (3) so that [] the KWader W/Trinstructor at Wangness should enter training at (4) on or about the 1st of December for a one-month's

Commo instructor's indoctrination course prior to resuming his duties at Wangness in January 1952. Six new HTFlower W/T candidates are to be recruited from the HBParson using Commo's own method of screening. These men will enter training under [] at Wangness during January 1952. The 4 W/T's now in training at Wangness will be moved to LCFlake for advanced on-the-air training under one of [] instructors. Identity (5), the exfiltrated Chestnut W/T will also continue his training with this group. He is presently in W/T training in LCDrink.

3. The training program for a cadre of HTFlower officers was discussed. [] stated that this could be carried out at (6) but was dependent on his recruitment program of ZASedan Ranger personnel whose units were at present being deactivated in HTStein. His present training staff was not sufficient to take on this additional work.

4. [] accompanied by [] then visited (7) where clearance was obtained on the return of trained agents to HBParson. Excellent cooperation was given us and the ZASedan officer-in-charge, a former friend of [] offered to help us in every way possible. [] brought up the question of withdrawing a cadre of approximately 30 men from HBParson for officer-training and then returning them to HBParson to take command. He also proposed that one or two platoons should be withdrawn and rotated in training at (6) under the supervision of [] training staff for a period of one month at a time. This would leave part of the HBParson continually receiving military instruction with modern weapons and small-unit tactics. This was entirely agreeable to (7), who commands the Labor Service troops.

a. The question of a replacement for [] was brought up and the desirability for replacing him with a ZASedan officer who had experience in handling troops in combat. [] stated, that at the time [] was recruited for BGFriend it was realized that he totally lacked experience in handling troops but that it was hoped this deficiency would be offset by his knowledge of the HTFlower language. Unfortunately, this has not been the case. Identity (8), officer-in-charge of the labor service troops stated that he could furnish a satisfactory replacement for [] and also an officer to command the second HBParson when activated. It is believed preferable to employ an unbiased ZASedan officer with no knowledge of the language which will thus prevent him from entering into the ever-lasting HTFlower intrigues and politics. Satisfactory interpreters are already available within the present HBParson.

b. [] has held up the activation of the second HParson pending ZASeal's decision on the joint Fiend/Valuable operational proposal for 1952-53.

5. [] then proceeded to the HTE exotic area where he visited Wangness accompanied by [] and (9). He found the morale of the 10 men being held there in an extremely bad state; the W/T operators have already been isolated at Wangness for a period of some five months without being away from the property. Identity (9) reported that unless these men were removed and allowed to live under normal conditions we were in danger of having some of them go off the deep end. The Wangness staff had been doing their best to keep them occupied both with work and recreation but after so long a training period were at a loss to provide the necessary diversion and recreation. [] suggested that the whole group be put to work out-of-doors as laborers to improve the grounds and property. He had a talk with the entire HTFlower group there and did his best to raise the morale and assure them that everything was being done to move them back among friends where they could resume a normal life. Unless some decision is reached by DTElder very shortly, [] is of the opinion that some of these men may desert from Wangness in spite of the staff's efforts to maintain a 24-hour watch on them. [] was requested to make every effort to press a decision from DTElder on the return of our men to the HParson. If permission is not granted for their return, [] requested him to attempt to arrange with [] and [] for employing them as laborers in one of the HTStein training areas, or in the event this proves impossible, to attempt to work out a plan whereby we would give them a bonus, proper documentation and turn them loose on the JBHomer economy. However, such shabby treatment for men who have been useful to us and proved their courage would certainly be poor propaganda for the HTCurio and the Committee and would put us in a most difficult position for further recruitment.

6. Depending on DTElder's favorable decision, [] was instructed to dispatch W/T trainees (10), (11), (12) and (13) from Wangness to LCDrink for advanced training, once DTElder's decision had been made. The returning aircraft would carry the 29 HTFlowers now being held in LCFlake for disposal. He is to notify (7), (8), in advance so that he may make the necessary arrangements for their return to HParson.

7. a. Permission was requested from ZRMetal for a local clearance on [] replacement. In the event the second HParson is activated, authorization for local clearance on its ZASedan commanding officer is also requested to enable him to take command at once. The indigenous second HParson

commander will be (14) with (15) or (16), or (17) as executive officer. [] will furnish the recruits from QKDimple or other sources which our proposed recruiting team will visit.

b. [] is to obtain from [] and also the new HBParson Commander, lists of possible officer-candidates. Identity (18) of Psychological Assessment will also send a screening team to HBParson for officer-candidate material.

c. [] will contact Commo and arrange for [] to enter training. He will also contact Commo to conduct screening at HBParson to select the best 6 W/T candidates for training at Wangness during the winter months.

d. [] is prepared to receive members of the Yarborough mission for further dispatch to [] who will mount operation from LCFlake in the spring. [] will notify [] in details of their arrival and will dispatch aircraft from LCDrink, or if impossible, airlift to LCFlake will be initiated via [] office. [] will brief [] prior to this mission's arrival in HTStein; W/T operator to be furnished by [] from LCDrink.

8. On or about 1 April, [] will send the first of the 1952 teams to enter training in Wangness or BGFiend's safe house at (19). Each group will consist of from 4 to 6 men; training will be for short-term, round-trip missions for the purpose of establishing contacts with the Flowerland armed forces and permanent-residence personalities within the country. It is also planned that they take in W/T operators and establish them permanently within Flowerland. These teams training will emphasize survival, safe-movement through hostile areas, reception committee organization, setting up communications networks and the establishment of contacts to be used in carrying out the plan for an eventual striking force.

9. Notes of Meeting between [] and [] - 21 November.

a. How many physically-fit unmarried HTFlowers can KMulcer supply for a second HBParson? [] to investigate and advise []

b. [] to develop a standard form agreement to be drawn up between HTNeigh and agents infiltrating into HTFlowerland to avoid future complications and obligations on the part of the Committee and HTCurios in the event of their capture, death, or defection to unfriendly powers.

c. [] to develop a form letter from HTFlowerland political party leaders to agents requesting them to cooperate with such personnel as may be directing operations. Such a letter appears to be much sought after by men being trained and dispatched by BGFiend and would greatly facilitate our handling personnel during training and dispatching.

d. [] to conduct a census of HTFlowerland manpower potential available throughout HBABash and the ZRGully to determine whether sufficient desirable personnel exists to support a third HEParson; two companies to number 200 each in strength under the new (7) labor company's T/O. The present company is authorized to maintain its original T/O of 250 men. The desirability of forming one company for Maledicts, the other for Melons, and the third (present company) to be used for dependents and physically-fit catch-alls was discussed. On further consideration, [] is not in favor of such a set-up as it may eventually lead to one political company entering into armed conflict with another. The present policy of integrating the various political factions into single military units will be maintained.

e. [] is to advise [] as soon as the HTFlower priest, pilot, doctor and other desirable personnel now in KMULcer (maximum of 10) have been rounded up and physically examined for departure to HEParson. It is essential that physicals, including chest X-rays and Wasserman tests are given. Records of the physical examinations are to be given to the conducting officer by [] when the aircraft stops in TPCredo to carry them to HTStein. [] will advise [] well beforehand on this movement to HEParson.

f. [] and [] agreed that it is advisable that BGFiend keep the Fiat station-wagon left behind by [] but which ZRMetal authorized to sell. In view of the increased activities of the TPCredo station, this car is badly needed. (Ref [] 1174, Para 4) was against this for security reasons but as the registration will be changed and this type of vehicle is one of the most commonly-used in TPCredo [] cannot see where any security risk is involved.

10. BGFiend's most pressing problem at the present time is the disposal of the exfiltrated agents and its agents which have undergone training but were not used due to the lack of sufficiently trained W/T operators. [] has attempted to dispose of them by various means and has come to the conclusion that unless DTElder allows them to re-enter the HEParson we must turn them out on the

JBHomer economy or find a means of employing them at one of the training areas. Neither the LCFlakes or KMULcers will allow them to return or remain in these countries and in addition they are a serious security risk here. An attempt was made here to ship them off via PBEEmpty from LCDrink but the men refused to sign the necessary papers. The present problem of feeding and housing them is occupying the full time of three of BGFiend's personnel, as well as being one of Fiend's largest operational expenses.

11. [] brought up the possibility of ZASenate establishing HBParsons for its North BGBruno bases. If such a plan materializes, it would certainly solve our disposal problem in the future.

12. Once the ZASeal's decision on the proposed Fiend/Valuable 1952-53 plan is forthcoming, [] will submit his operational plan for the coming year.

13. The next joint BGFiend meeting is scheduled to be held at HTE exotic during the week of 24 February 1952. It is proposed to hold the meetings each day at Wangness which will be vacant except for 6 W/T operators in training, who will be kept isolated from Fiend personnel.
