1. PROJECT: BGFIEND (in HTSTEIN only)
2. AUTHORIZED DURATION: Indefinite
3. ORGANIZATIONAL DATA:

A. [ ] and [ ] graduated from the Identity (1) on 6 March and were both commended by the Commanding Officer..

B. [ ] entered on duty at HTE exotic 20 March.

C. [ ] was relieved by [ ] at close of business, 28 March.

4. SUMMARY OF ACTIVITY:

A. Apple Tree Team Movement. [ ] departed HTE exotic 10 March, arriving in HBJoint 12 March. With excellent cooperation on the part of the DYClaim HBJoint station, [ ] executed the following plan:

At 0545 hrs., 15 March, [ ] had a rendezvous with the Apple Tree Team members. Picking them up in two cars, provided by the HBJoint DYCluck station, he proceeded to a second rendezvous point outside Identity (2) where he was met by two cars from the BGMiddy station at 1500 hrs., 15 March. At this point, the Apple Tree Team members changed into Identity (3) provided by the BGMiddy station and, with orders cut for them by that station, crossed the HBFairy-JBHomer border without incident. At a third rendezvous made in FJLaugh at 2300 hrs., 15 March, [ ] and the Apple Tree Team changed to cars driven by [ ] and [ ]. This party proceeded to Identity (4) via HTE exotic, arriving at the destination at 0630 hrs., 16 March. The Apple Tree Team remained at Identity (4) for ten days, during which time they were visited on three occasions by [ ] and [ ]. On 26 March [ ], [ ] and [ ] moved the Apple Tree Team and their voluminous luggage to Identity (5) where a rendezvous was kept with an Identity (6). The group was on loaded and took off for LCDrink at 1415 hrs., 26 March.

B. W/T Candidates Movement. On 10 March, [ ] and [ ] escorted the six selectees for W/T training from JBParson to Identity (7), where they are now undergoing training.

C. JBParson. On 24 March, Identity (8) was found dead at his post at JBParson. The cause of death was determined to be a bullet from his own rifle fired into his head. Although the TPETude investigation has not been formally completed, [ ] has been assured by the investigator that the incident will be established as a suicide. [ ] indicates that from all information he can elicit from Identity (8)'s confederates, the motivation for his act was despondency and concern for the fate of his family still in KMWaahoo. TPEtude report on this matter will be forwarded to BGMiddy and ZRMetal as soon as possible.

D. Defection of Identity (9). Plans were initiated by [ ] and [ ] to force the defection of Identity (9) while attending a meeting in XN Lemur. Because [ ] presence was required in BGMiddy, [ ] was selected to act as Case Officer for this operation. [ ] made one trip to ZRARrow from BGMiddy on 25-26 March to secure the cooperation of the ZRARrow station for this project. A complete report on this operation will be submitted at the earliest possible time.

5. ACTION PENDING - FIELD

A. The HTE exotic Station is standing by to receive [ ] and Identity (9) should the defection attempt be successful. These two KMWaaahos will be taken to a safe house here where tape recordings will be made of [ ] debriefing Identity (9). These recordings will be carried to TPCredo for use by BGFriend propaganda media.

B. On 28 March, [ ] reported that Identity (10) had been seen for several days in the vicinity of JBParson. [ ] is preparing a report on this matter which will be forwarded upon receipt.

C. Papers are now being prepared for Identity (11)'s trip to TPCredo. The major purpose of his trip is to pick up genuine KMULcer cachets for reproduction here. With stamps prepared from these cachets by DYClaim, HTE exotic, Identity (12)'s can be made up and pouched to [ ] for all the KMWaaahos in KMULcer who are now without documentation.
