4. SUMMARY OF ACTIVITY:

A. Defection of Identity (1). From 7-17 April this office was on a stand-by basis to play its part in the event the defection plan succeeded. A complete report of this plan is contained in the April Progress Report prepared by [] [], who conducted the operation.

B. Black Movement of Identity (2). In accordance with WASHG-36115, the black movement of Identity (2) was projected with DYMACULE's excellent support. The authority to proceed in conjunction with DYMACULE was vested in the writer by [] [] on 24 April. During the preliminary "interrogation" of the five KMWAAHOOS selected from JBPARSON and conducted by DYMACULE representatives, it was first learned Identity (2) had been dismissed from JBPARSON because of a letter he had written complaining of conditions at that place. [] [] intercepted this letter and presented it to [] [] who, upon reading it, dismissed Identity (2). Thus the preliminary interrogation, designed as a cover for Identity (2)'s removal, proved to be a source of real information not revealed by BGFIEND representatives at JBPARSON. [] [] informed [] [] of this turn of events. [] [] then canceled the air-movement which had already been fixed.

Again with DYMACULE support, Identity (2) was initially contacted by [] [] and proved most cooperative in agreeing to proceed to TPCREDO. The air-movement was again arranged by [] [] and will take place on 7 May.

The true knowledge of facts surrounding this movement is unknown to [] [] and all other members of JBPARSON.

C. Code Aptitude Test. In accordance with [] [] a code aptitude test was conducted by Commo representatives at JBPARSON on 30 April. Selection of the KMWAAHOOS tested was based on the February screening conducted by [] []

Of eleven men tested, two passed. A clearance request has been cabled to ZRMETAL and once these men are declared eligible, both in the light of security and health, it is expected they will join the three other KMWAAHOOS presently undergoing training in HTSTEIN.

D. Identity (3)'s trip to TPCREDO. (Ref. March Progress Report, Action Pending in Field, Item C.) On 24 April,

Identity (3) was dispatched overtly to TPCREDO carrying a Combined Travel Document in lieu of Passport containing a KMULCER visa. He returned overtly to JBPARSON on 30 April. If the result of this test case proves satisfactory to [] and [] in all respects, this office will be prepared to furnish them with future needs regarding papering of KMVAAHOCS in KMULCER now without documentation.

E. Wangness Estate. On 2 April, Roger T. Wangness was accompanied by [] and the writer to the Wangness Estate where the owner made a personal tour of the complete establishment. The condition of the estate, following 18 month's occupancy by BGFIEND, was found in good order by the owner. A few minor repairs were needed. By the end of the month these repairs, consisting principally of the replacement of broken window panes, were completed.

On 30 April, a JBHOMER representing Roger T. Wangness and the writer made a complete check of estate items inventoried in March, 1951. Once again satisfaction was expressed. Without fear of future contradiction, the final meeting between Wangness and BGFIEND representatives, on or about 15 May, terminating the lease agreement, should draw the Wangness phase of BGFIEND to an amicable conclusion.

F. JBPARSON. All preliminaries for [] to enter a JBHOMER T.B. Sanatorium are complete. Word from the Sanatorium is being awaited at JBPARSON announcing that bedspace is available. [] should be entered into the Sanatorium by 15 May. The JBHOMER doctor who examined [] stated that his condition is not critical. He added that a 4 month period of treatment should remove all active symptoms. Meanwhile, [] is kept isolated at JBPARSON on an unofficial status (ref. A []).
