1. PROJECT: BGFIEND (in HTSTEIN only)
2. AUTHORIZED DURATION: Indefinite

4. SUMMARY OF ACTIVITY: ¹⁹⁵

A. On 7 May, Identity (1) was finally moved back to TPCREDO. On 27 May, []' office informed [] that Identity (1) was being returned to HTEXOTIC and that [] was to meet. It was thought Identity (1) could be returned to a local civilian Displaced Person's Camp, but an investigation into this possibility revealed that the local Camps would not accept him on the ground that he was not awaiting emigration. Notice of this was sent to the various BGFIEND stations. A later investigation by the undersigned with a local KMFARCE contact opened a disposal door into a Camp formerly under that Organization's control; meanwhile however, [] discovered a means of disposal through a DYCLUCK channel in BGMIDDY. While this channel is being arranged, [] is maintaining daily contact with Identity (1) who is living in an out of the way pension in HTEXOTIC.

B. Wangness Estate. A final meeting between the Wangness' attorney and [] took place at the estate on 16 May. The purpose of the meeting was to finally satisfy both parties that all agreements had been met before a release would be drawn. The attorney confirmed the results of an earlier estate meeting between representatives of both parties. Late in May the attorney notified the undersigned that Wangness confirmed all findings; thus informal notice has been given that the lease agreement is terminated as of 30 April. Formal notice will be issued shortly and sent to [] for his signature as BGFIEND representative.

C. JPARSON. The dispatch 74-CRIFG, received from [] in late April, prompted the undersigned to arrange facilities whereby chest x-rays of all KMWAHCO personnel would be taken. This being accomplished in early May, the results showed that all but four KMWAHOOS are clear of tubercular traces. The four doubtful cases will undergo a more thorough physical to determine their true condition.

In early May, representatives of Identity (2), clearing through [], contacted [] announcing their intention to conduct a screening program at JPARSON with the hope that two candidates would be selected for monitoring work on Cyprus.

One KMWAAHOO, Identity (3), qualified and was selected. Arrangements are being made to send Identity (3) on his way. He is expected to leave JEPARSON about 12 June.

[] entered a JBHOMER T. B. Sanitarium on 12 May. (Ref. April Report, Summary of Activity, Item F.)

Identity (4) was dispatched to TPCIBDO for the same purpose as was Identity (3) of April Report, Summary of Activity, Item D).

D. BGFIEND Safe House. In mid-May, word was received by this office that the maid at the BGFIEND safe house in JBHOMER was to emigrate to HTCURIO on 24 May. Thus no indigenous personnel remain at the site, and none will be assigned by DYMACPIE due to existing regulations. The undersigned visited the site, removed all valuables and secured the premises. DYMACPIE will make periodic checks of the property. In the meanwhile, this office is awaiting decision from [] to either hire a maid or relinquish the property.

E. Miscellaneous. Fifty food kits and 24 medical kits prepared by [] were dispatched by air to [] 28 May.

5. ACTION PENDING: FIELD

A. On 29 May, 21-CAGMG, announcing JEPARSON recruitment proceedings for the ZRELOPE Political Action Program, was received by this office. This project will be carried out in close conjunction with ZRELOPE. Biographies of nominees will be submitted to Headquarters once a screening program is completed.

B. [] has notified the undersigned that DTELDER Labor Service will offer a replacement for [] on TDY status until a permanent replacement is assigned by Headquarters. [] has kindly offered to aid [] in "getting replacement into saddle"; assistance graciously accepted. This change over is scheduled to take place early next month.

C. Formal agreement officially releasing BGFIEND from all Wangness ties.

D. Decision from [] re BGFIEND JBHOMER safe house.

8. RECOMMENDATIONS AND COMMENTS

Within the past six weeks, ten to twelve KMWAAHOOS resigned from JBPARTSON at their own request. The undersigned conferred with [] concerning this series of resignations and received this information: the majority of those who resigned were malcontents; the other few resigned because recruitment of JBPARTSON KMWAAHOOS has been at a standstill; they considered themselves forgotten men. [] added that this attitude is gaining force among the KMWAAHCO complement. It is the opinion of the undersigned that 239-CRIAG, in which [] and [] offer their views re JBPARTSON-HTNEIGH relations, would offer much to solve this "forgotten men" attitude.
