OATH OF ALLEGIANCE READS "UNDERSIGNED PLEDGE ALLEGIANCE HTNEIGH, AIMS FOR WHICH IT STANDS, AND WILL RESPECT FOLLOWING: WILL NOT ASSOCIATE WITH ANY FOREIGN POWER NOT AFFILIATED HTNEIGH; WILL NOT COLLABORATE WITH ANY POLITICAL ORGANIZATIONAL OR PERSONS NOT REPRESENTED WITHIN HTNEIGH; WILL NOT CONTRIBUTE MORALLY, PHYSICALLY, FINANCIALLY TO ANY POLITICAL ORGANIZATION OR PERSONS DIRECTLY OR INDIRECTLY NOT ACTIVELY PARTICIPATING WITHIN HTNEIGH".

PROTEST DISCHARGE TO HTCURIO ARMY AUTHORITIES. UNDER JBPARSON REGULATIONS IS NO WAY [] CAN STOP PROTEST ALTHOUGH DISCHARGE CLEARLY POSSIBLE UNDER ANNEX F STATING: "MEMBERS MAY BE DISCHARGED FOR CREATING DISTURBANCES ADVERSE TO EFFECTIVENESS OF MORALE AND PREJUDICIAL TO HTCURIO FORCES."

4. FEEL FINANCIAL CONTRIBUTION MADE TO PROFS BY JBPARSON MALEDICTS SUFFICIENT CAUSE DISCHARGE VIEW ANTI-HTNEIGH PRINTED MATERIAL NOW BEING DISTRIBUTED WORLDWIDE BY PROFS. BELIEVE ADVISABLE HQS TAKE ACTION BACKSTOP [] , APPEALS OFFICER WHO WILL BE CONTACTED BY MALEDICT IS IDENTITY 1, MUNI MIL POST KNOWN TO [] .

5. FOR DIR/[] ONLY: FYI, DURING [] ABSENCE [] [] OBTAINED CONCLUSIVE EVIDENCE SIMILAR REFERENDUM HELD BY MALEDICT COLONY LONDON 10 JAN. THIS OBVIOUS SNEAK EFFORT ON PART PROFS WREST CONTROL MALEDICT FROM MALAMENT. CONFERRING WITH MALAMENT SOONEST BUT HIS LETHARGY SUCH MATTERS BIG HANDICAP BEATING PROFS PUNCH.
