

20 Mar 59 fr [] Dr. SCHREITER apparently had to come in to speak to a secretary in Dr. KUTZBACH's outer office while Dr. KUTZBACH and [] were casually chatting just inside the door. Dr. SCHREITER greeted [] stiffly and departed. He and Dr. KUTZBACH very carefully ignoring each other completely. Apparently neither is willing to even try putting a good front to the befreundete Seite; they despise one another so intensely.

Apr 59, ABC check list from [] Regierungsrat (per statement of V-11400 to [] on 2 Mar 58 - EGSA 4596, 7 Mar 58). Referent. Speaks good English and also Czech. Is responsible for build-up material clearance for all Fed-Rep D/A cases as of Mar 59. Is in personal liaison with MAD Munich. He and KUTZBACH apparently despise one another.

8 Apr 59 fr [] Dr. SCHREITER, per his own and KUTZBACH's statements, is responsible for clearance of Spilmaterial. He handles clearance of Spilmaterial for other German services and deals with them in regard to obtaining clearance for WUMINS and other services of material concerning their responsibility. Today he stated that he would have to consult MAD Munich tomorrow concerning the [] material which touches upon industrial production for the Deutsche Bundeswehr.

Apr 59 fr [] 1. Dr. SCHREITER gets along well with GIBNER and he is interested in and well informed on the matters handled by his brother-in-law, GIBNER. He is also well informed on GIBNER's cases. However, with regard to KUTZBACH, it is noted that Dr. SCHREITER has had two discussions with [] and one with the Deputy Chief of MAD, Munich, concerning Spilmaterial for the [] operation and yet he does not know that KUTZBACH is taking it over in accord with arrangements made weeks ago.

2. Dr. SCHREITER visited Vienna over Easter where he again stayed with his mother. (NOTE: It seems that he takes too many days of "leave." In view of his long-standing wish to be assigned to Vienna (to conduct liaison), it seems that at least some of his visits to Vienna may entail operational business or liaison or both - or else he has a real GIBNER complex.)

3. Dr. SCHREITER boasted that he has an excellent liaison relationship with MAD and that MAD is most cooperative. The CAWETA problem is still as serious as it was two years ago. (He said WUMINS's problem with CAWETA is like HUBACK's with GIBNER.) He handles Spilmaterial for the RV as well as MAD as the holder of the Federal Republic office responsible for clearing all Spilmaterial. (NOTE: This confirms suppositions in EUSA-36073.)

22 Mar 60 [] [] SCHREITER and GIBNER are on a "per du" basis and are close friends.

22 Apr 60, Keith F. Lauer for

GIBNER, in commenting on the turn-over of the Hers LIBERMAN material to SCHREITER (see below), stated that SCHREITER's principal activity was the handling of cases involving the [] Eastern []'s use of firms and individuals engaged in East-west trade. As near as I know, SCHREITER's specialty has never been clearly defined, but based on the few dealings I have had with him (Jimon GILBERT, Hers LIBERMAN, Ferdinand deSTREBARNEY) it would appear that the above comes close to defining SCHREITER's area of activity.

27 Apr 60, [] GIBNER: Dr. SCHREITER will replace GIBNER.

29 Apr 60

1. STUPPER said he had been quite busy briefing SCHREITER on his job and expected [] to take it over within the next two weeks to one month. I asked STUPPER what he would be doing and he said it wasn't figured up. He was either unwilling or unable to say what he thought he would be doing, nor would or could he state if he would continue in liaison with []
