GERMAN BUSINESSMAN ERICH OLBRUCK (AFRICAN CONSULTANTS CO, STUTTGART) SUSPECTED [] OF BEING GIS, NEGOTIATED DEAL THRU KHAR BUSINESSMAN STRATIS LIMNIOS AND PARTNER MAHMUN EL MARDI. DM 83,500 COMMISSION ON DM 600,000 EQUIP PURCHASE SPLIT BY OLBRUCK, LIMNIOS AND MARDI.
3. OLBRUCK WHO VERY CLOSE TO GERMAN AMB KHAR, DE HASS, CLAIMED TO QPPRIG TO HAVE DONE CONSIDERABLE ESCORT WORK WITH MIN INTERIOR MAQBUL WHILE LATTER RECENTLY IN GERMANY. THIS CONTRIBUTES TO THESIS HE MAY BE UPHILL MAN KHAR.
