PRISONER: O/Stubaf PAEFFGEN, Theodor Leiter VI-D RSHA DATE: 19 September 1945

1. PERSONAL DATA

PAEFFGEN was born in KOELN 12 Jun 10. He finished his law studies at BONN (1933) and passed the state final examination at KOELN in 1936.

The following is a summary of his subsequent career:

- 1937 Joined the NSDAP
- May 38 Appointed Hauptamtlicher Mitarbeiter SD Haupt Amt BERLIN, Dept I-2 under SCHELLENBERG
- Jun 40 Assigned to SD Aussen Dienst Stelle METZ to make weekly reports on morale and general conditions
- Jun 41 Re-assigned to SD Haupt amt BERLIN, abt III to report daily to HEYDRICH and the Amt Chefs on the location of SD Einsatz Gruppen (task forces) on the Eastern Front
- Nov 41 Assigned to Stapo Stelle TILSIT as deputy to Stubaf BOEHME
- Apr 42 Assigned to Stapo Stelle ALLENSTEIN-BIALYSTOK as deputy to Stubaf ALTENLOH
- Aug 42 Appointed Gruppen Leiter VI-D RSHA. Held this position until Apr 45.

2. ADMINISTRATIVE DATA

PAEFFGEN was arrested at BAD TOELZ 5 Aug 45 by CIC Det SOE-R. He arrived at USFET MIS Center 7 Sep 45 and was accepted at request of G-2 (CIB), USFET. Arrest report dtd 6 Aug 45 accompanied him. Cf CPI Pink Cards 1644; 400,002; and 96710.

- a. Personalities, activities, and history of organization of VI-D RSHA.
- b. VI-D sources and agents in neutral countries.
- c. SD and Gestapo activities and personalities in Lorraine, Poland and Russia.
