1. SUBJ STATES ACCEPTED EMPLOYMENT WITH GERMAN SERVICE BELIEVED UPSWING, DEFINITELY NOT CAVATA, EFFECTIVE 1 SEPT 56: EXACT FUNCTIONS UNCERTAIN. SAYS SALARY WILL BE 1500 DMW MONTHLY. SUBJ TOLD COULD CONTINUE TALK TO AMERICANS BUT ONLY ON USSR EXPERIENCES. AS RESULT DEBRIEFING STOPPED IMMEDIATELY. SUBJ AND [] PARTED GOOD FRIENDS. SUBJ ACCEPTED NO MONEY FOR TIME SPENT WITH [] IN ORDER NOT JEOPARDIZE FUTURE POSITION. REQUEST FULL REPORT ANY DEVELOPMENTS RE ABOVE.
2. SUBJ SPOKE WITH [] AFTERNOON 31 JULY AND CA SIX HRS 1 AUG IN SUBJ'S HOUSE, FULL DAY 3 AUG [] HOTEL. WAS ILL 4-5 AUG. APPARENTLY MADE DEAL MENTIONED PARA 1 ABOVE THRU FRIEND EVENING 5 AUG AND IMMEDIATELY ADVISED []
