PENDING THIS SUBJECT ADEQUATELY PAID AND STATUS OF "FREIE MITARBEITER". SUBJECT'S IMMEDIATE ASSIGNMENT WRITE LENGTHY ACCOUNT HIS KNOWLEDGE "ROTE KAPELLE" AND EXPERIENCES UP TO PRESENT. FIRST INSTALLMENT EXPECTED SEPT.

(SEE PARA 2 BOHN 4369 (IN 4376)). ^{8/1076} WHEN ASKED WHAT HIS CONTROL EXISTED, R
THOUGHT HIS HAD LITTLE TROUBLE CONVINCING SUBJECT HE WOULD NEVER HAVE FUTURE
IN WEST (ROLE HEYDRICH CASE, ETC.) AND BESIDES HE TECHNICALLY A DESERTER WHO
HAD VOLUNTARILY GONE OVER TO RUSSIANS WITH HIS PRISONER ALIAS KENT. (R
EMPHASIZED UPSWING CAREFUL NOT TO BRING UP DESERTER ANGLE VIS A VIS SUBJECT)
