The following information, discovered while reviewing an unrelated file, is forwarded as being of possible value to any effort which may be made to exploit CARETINA.</p> <p>2. In February 1957, Dr. Georg DUESTERBERG, son of the Weimar Republic political leader, sought the assistance of Mr. Hans R. OHRBERGER, American Consulate General in Munich, in securing background information on Hans Dietrich ERNST, born 3 November 1908 in Oppeln, Former SS Sturmabfuhrer in the SD, unpunished war-criminal, and subject of many derogatory traces. Duesterberg reported that ERNST was then resident in LEER, Ostfriesland, at Lindenstrasse 6. (The desired information, which he needed to bar ERNST from employment by the West German Defense Ministry where he was himself employed, was given him several months later by an FOB case officer. The file is available if required.) <i>in 1957, Ernst resided in Leer, Ostfriesland, at Lindenstrasse 6. Ernst was a possible contact of subject of []</i></p> <p>3. Annex H of the reference dispatch includes photographs of a letter dated 7 July 1957 to one "Roland" from "Dieter" which contains a reference to CARETINA and was presumably given to him by "Roland." The envelope identifies "Dieter" as "ERNST, Leer, Ostfriesland, Lindenstrasse 6." There can be no doubt that the two men are identical.</p>
