Dr. USO : I do not know his identity. I can only state the efficiency of his work either in the help given to most numerous persons arrested by the SS, among whom myself, or for the precious information supplied by him.

BARONE IARRILLI He was introduced to me by VERO ROBERTI since December 1943 as a person in possession of transmitters; although I contacted him very seldom our relations remained good especially as I knew him to be an old friend of the Messers DE VALLIO from GENOVA, who were absolutely reliable persons, always ready to do anything for the anti-german cause. I never said anything concerning my work to IARRILLI, but, he was the one who informed me of the charge with which I had been accused since February when the SS were searching for me. He was very useful to me in several occasions in helping out some of my collaborators in legalizing their position, putting at my disposal his house and his car in any occasion, and as far as I am concerned I exclude that he had with the Germans other relations than those in which he was forced to use his influence upon them in order to help ~~anti-fascists~~ anti-fascists. In the occasion of my arrest under a false name, he overcame the basic diffidence on my identity by stating that he was ready to respond with his life for the truthfulness of my false identity.
