1. PARILLI UTILIZED BY ODEUM CONNECTION ORDER OF MALTA; OTHERWISE SUSPECT AND HANDLED CAREFULLY.
2. ~~SCHNEIDER~~ TURNED PARILLI REQUEST FOR AID TO DOLLMAN SEVERAL MONTHS AGO.
3. PARILLI IN MUNICH AREA EARLY JUNE 49; NO CONTACT ODEUM. BUT MET WITH GAEVERNITZ, SWISS PROFESSOR THUSMAN S.B. OBER GRUPPENFUHRER WOLFF, GUIDO ZIMMER (ALSO RECD KARL GUIDO ZIMMER*) (PARILLI'S SECRETARY), A PAINTER PADUA AND FORMER GENERAL GOETIGER (ALSO RECD ROETIGER).
4. HIGH LEVEL AND PROVEN ODEUM SOURCE REPORTED THAT WOLFF CAME TO HIM IMMEDIATELY AFTER TALKING WITH GAEVERNITZ WHO TESTIFIED WOLFF'S BEHALF BEFORE SPRUCHKAMMER. WOLFF REPORTED GAEVERNITZ REPORTED CONVERSATION IN SWITZERLAND WITH ALLAN DULLES EN ROUTE MIDDLE EAST. ACCORDING TO WOLFF, GAEVERNITZ STATED THAT HE (GAEVERNITZ) WAS TO BE THE SUCCESSOR TO DULLES IN EUROPE. THIS GAEVERNITZ-PARILLI-DOLLMAN CONNECTION MAY EXPLAIN PARA 2 REFERENCE.
5. ODEUM OBVIOUSLY EMBARRASSED JANUARY TO CLOSE CONNECTION PARILLI AND NOW RETRENCHING.
