B. Aims and Objectives

1. To furnish OFC with the services, experience and background of Dr. Gustav Hilger to assist in the planning of its operations and to make Dr. Hilger's services, which have already been requested, available to various agencies of the United States Government, on a consultation basis, in connection with innumerable, continuing matters which call for policy decisions.
2. To place Dr. Hilger under the benevolent influence of the United States for possible future use in the government of Germany.

C. Headquarters and Area of Operation

D. Cover

- 1. Dr. Hilger will use his real name while in this country, but will remain fairly inconspicuous. It is hoped to obtain for him some connection with Georgetown University in Washington, for which organization he will actually do very little work.

F. Headquarters Action
