1. Subject's name appears in reference in connection with [ ] statement concerning his activities while attending the July 1955 Geneva Conference as a so-called "journalist." According to [ ] he was greeted one day in Geneva by the Czech emigrant, Mrs. PEKELSKA. This person is undoubtedly identical with Marie PEKELSKA aka PEKELSKY (Identity 1), wife of Vladimir PEKELSKY (Identity 2), and a former ZIPPER agent who was dropped in May 1952 (NSA-10216, 5 August 1952). Shortly after the exchange of amenities between Mrs. PEKELSKA and [ ] another journalist identified as Heinz STADLMANN asked [ ] who this woman was. STADLMANN then informed [ ] that on the previous day he had seen Mrs. PEKELSKA in the company of [ ] subject, whom STADLMANN further described as a Communist agent. Apparently, this aroused [ ] interest and he later managed to have STADLMANN point Subject out to him. [ ] maintains that this is the extent of his knowledge of Subject and that he has never actually met him.

2. Subject was further identified by Mrs. Marie-Theresia PEKELSKA (born 1 January 1920 in Miesditzsch, CSR; residing Munich 25, Seelandstrasse 25; telephone 12 688) when she was interrogated by the Security Group in connection with the [ ] case. Mrs. PEKELSKA first met Subject at the Geneva Conference (on Far Eastern problems) held in 1954; at this time, she reports, Subject appeared to be most interested in Communist matters in general. Subject and Mrs. PEKELSKA met again at the Geneva Conference of July 1955, by which




time Subject had switched his attention and interest to emigre affairs. Subject made a special effort to come in contact with Mrs. PEKELSKA and her husband at this conference and at one point suggested to them that they should consider returning to the CSR. Although Subject stated to Mrs. PEKELSKA that he is an employee of DEFA, she is of the opinion that he actually is a member of an East Zone IB or security office. Subject appears to have many contacts among journalists from the Ruhr area, and Mrs. PEKELSKA is under the impression that his parents live in the Ruhr. Finally, there are statements appearing in the Security Group interrogation reports of both [ ] Mrs. PEKELSKA which indicate that the Security Group knows, or has reason to suspect, Subject to be a contact of Max Edward WORSIG aka WORSIG, the ADN "correspondent" who introduced [ ] to the RIS man, Ivan Wladimorovitch KUSHIN aka KOUCHIN, while he was in Geneva in July 1955.

3. The Heinz STADELMANN mentioned by [ ] in his interrogation report is identified by him as being a journalist for the newspaper DIE WELT. (See page 9 of the Security Group Interrogation Report, 14 December 1955, from Bonn.) He is undoubtedly identical with the Heinz STADELMANN who was the subject of an Operational/CADORY name check request forwarded to FOB in HQQA-63131, 26 May 1955. FOB's reply states: "Heinz STADELMANN, born 19 June 1925 in Berlin, was a ZIPPER agent (Identity 3) who was dropped on 19 May 1954. He is listed in FOB files as living in West Berlin and as an economic source." (NYLA-14826, 11 July 1955) According to information on a pistol permit issued to STADELMANN, he is six feet tall, weighs 167 lbs., had dark blond hair and blue eyes.

4. It is requested that all addresses provide FOB with name traces on Guenter Reinhold KLEIN. We are particularly interested in evidence that he is in fact a contact of Max WORSIG. COS Only: The reason for the trace request on STADELMANN in HQQA-63131 was not sent to FOB; however, it is noted that he was assigned a cryptonym (Identity 4). Please inform us if he is a KUBARK agent and/or forward all pertinent biographic data to this base.
