SMABOVE has advised that their interest in Subject was not based on a visa application but that [] from his alleged association with Milorad [] Canadian citizen of Czech origin who was imprisoned by the Czechs from July 1960 until late December 1961, and with Miloslava KUTACEK nee SIREK, born 28 December 1915, at Ervenice, Czechoslovakia. Mrs. KUTACEK (who lives in Canada) was engaged to COP at one time and when he was being held by the Czechs, COP was questioned about Mrs. KUTACEK and her association with the CIC in 1951. SMABOVE has recently reinterviewed Mrs. KUTACEK and she stated that she had at one time worked for an individual named PEKELSKY, whose first name she recalled as possibly being Josef, who had claimed to be working for the CIC.</p> <p>2. Ottawa raised with [] the question as to whether the original trace request, reported in EGSA-11302, 30 January 1964, represented a departure from policy which strictly limits the SMABLE representatives abroad from dealing in other than Visa Control work. [] emphatically denied this and stated that there seemed to be a natural tendency for their SMABLE officers abroad to go beyond the rather confining visa work and that periodically it was necessary for SMABLE Headquarters to remind them not to do so.</p>
