ON 9 MARCH 1970 CAVIRIL REPRESENTATIVES CONTACTED TPFEELING SECURITY OFFICE ADVISING THEY RECEIVED REPORT FROM THEIR BONN HDQS THAT FORMER "DIZTAG INTERIOR MINISTRY MAN WHO RESPONSIBLE FOR CE ACTION DIRECTED AGAINST TPFEELING STATED, FOLLOWING IN LATE 1969: DIZTAG HAS CZECH/SLOVAK MARRIED COUPLE AS AGENTS THEIR SERVICE. THIS COUPLE WORKED TPFEELING 1958-1960 AND MAY STILL BE SO EMPLOYED. REPORTEDLY TRAVELLED FREQUENTLY TO SWITZERLAND. DIZTAG REPORTEDLY ALSO HAD ANOTHER MALE AGENT, DESCRIBED AS PARTIALLY BALDING, WHITE MALE WITH FRINGE OF RED HAIR". CAVIRIL REPS PRESUMED FROM WORDING THEIR REPORT THAT RED HAIRED AGENT ALSO WORKING TPFEELING. NO FURTHER DETAILS. THEY REQUESTING ANY AND ALL ASSISTANCE.

2. AT FIRST BLUSH TPFEELING APPEARS TO EMPLOY SOME FORTY BALD MEN AND TWENTY TO THIRTY COUPLES WHO MIGHT FIT DESCRIPTION. UNLESS ADVISED TO CONTRARY, WILL POINT OUT TO CAVIRIL IMMENSITY OF TASK SINGLNG OUT LIKELY CANDIDATES DUE DEARTH IDENTIFYING INFO. WILL ASK THEM PROVIDE FURTHER INFO, IF POSSIBLE, TO NARROW FIELD.
