REUR []-312 RPT []-312, PARAGRAPH THREE: INCOME TAX STATUS OF SUBJECT IS CLARIFIED AND IMMIGRATION OF SONS TO US RPT US DISCUSSED IN OUR MEMO DATED 26 RPT 26 OCT 49 DISPATCHED BY POUCH TODAY. FURTHER DISCUSSION OF IMMIGRATION QUESTION FOLLOWS:

SINCE SUBJECT'S SONS ARE OF NO RPT NO SUBSTANTIAL INTELLIGENCE INTEREST IN THEMSELVES, THEY CANNOT BE BROUGHT INTO THE US RPT US UNDER CIA RPT CIA SPONSORSHIP AND WITH DIRECT CIA PARTICIPATION IN THE CASE UNLESS 1.) A SPECIFIC PRIOR COMMITMENT TO THIS EFFECT WAS MADE AS A PART OF HIS ORIGINAL AGREEMENT TO COME TO THE US, OR UNLESS 2) SUBJECT'S FURTHER EXPLOITATION CANNOT BE ACCOMPLISHED WITHOUT THIS SERVICE AND IS IMPORTANT ENOUGH TO JUSTIFY THE EXPENDITURE OF TIME EFFORT AND MONEY WHICH IT INVOLVES. NUMBER TWO ABOVE IS CLEARLY NOT RPT NOT TRUE IN THIS CASE, BUT THERE IS SOME INDICATION THAT NUMBER ONE MAY BE. THEREFORE PLEASE DETERMINE AND REPORT WHETHER ANY PROMISE TO THIS EFFECT WAS EVER MADE, AND, IF SO, BY WHOM, WHEN, WHERE, ITS EXACT TERMS, AND UNDER WHAT CIRCUMSTANCES AND CONDITIONS. IF THERE HAS BEEN NO SUCH PROMISE, SUBJECT IS IN THE POSITION OF ANY OTHER IMMIGRANT WITH THE SAME PROBLEM. IN THIS EVENT WE SHALL OF COURSE DO ALL WE CAN TO HELP HIM WITH ADVICE AND ASSISTANCE TO THE EXTENT POSSIBLE WITHOUT INVOLVING CIA RPT CIA OFFICIALLY, BUT CAN COMMIT OURSELVES NO FURTHER.

WE ARE CHECKING HERE ON THE POSSIBILITY THAT SUBJECT'S OWN IMMIGRATION PAPERS COVER THE SONS AND WILL REPORT TO YOU FURTHER.
