THE GENERAL COUNSEL WILL BE ASKED TO SPARE NO EFFORTS IN THIS CASE, THE APPLICATION BEING BASED ON STRONG MORAL COMMITMENT RATHER THAN POSITIVE INTELLIGENCE VALUE. THE DELAY IN ANSWERING YOUR LAST TWX OCCURED BECAUSE WE SPENT SOME TIME LINING UP SUPPORT FOR THE APPLICATION.

IF HE STILL FEELS THAT BETTER RESULTS CAN BE SECURED OUTSIDE CIA, PLEASE ASK HIM AT LEAST TO KEEP US INFORMED SO THAT NO WIRES WILL BECOME CROSSED.

3. WE UNDERSTAND THAT HE HAS BEEN REQUESTED FOR PERTINENT INFORMATION ON HIS SONS BY OFFIE RPT OFFIE, WHO WAS NOT RPT NOT AWARE THAT WE HAD ALREADY ASKED HIM FOR THIS DATA AND RECEIVED IT. ANTICIPATING RIGHTEOUS INDIGNATION ON POPPE'S PART OVER SUCH DUPLICATION, WE RECOMMEND THAT YOU OFFER TO GET ANY NECESSARY WORD TO WASHINGTON FOR HIM.
