NOTES DEAL WITH RESULTS OF CASAROLI'S RECENT VISIT TO MOSCOW (QUOTE EXTREMELY POSITIVE UNQUOTE), CHELI'S PLAN TO VISIT PRAGUE CIRCA 20 MAR TO NEGOTIATE NOMINATION BISHOPS, POSSIBLE VISIT BY POPE PAUL TO POLAND IN AUGUST, AND CHELI'S PLAN VISIT HUNGARY.
