1. [] HAS NO CONTACT WITH LOCAL FJHUMMING PERSONNEL. WE ARE UNAWARE OF BASIS ON WHICH FJHUMMING OPERATES HERE OR THE NATURE OF ITS AGREEMENTS WITH THE GRC AND THE EXTENT TO WHICH FJHUMMING IS IDENTIFIED TO THE GRC WITH JKLANCE INTERESTS.

2. IN GENERAL SENSE OF US-CHINAT RELATIONS, THOUGH KEEPING IN MIND OUR BASIC LACK OF KNOWLEDGE OF FJHUMMING RELATIONSHIPS AND ACTIVITIES, [] CANNOT FORSEE ANY UNUSUAL PROBLEMS THAT MIGHT ATTEND CLOSING DOWN THE FJHUMMING STATION, AND IS INCLINED TO AGREE THAT ADVERSE REACTION WOULD BE MINIMAL, PARTICULARLY SINCE FJHUMMING TARGET IS MHARSH, NOT COMMUNIST CHINA. GIVEN RECENT REPORTING THAT SOME GRC UNITS HAVE SUGGESTED TIES WITH MHARSH, IT CONCEIVABLE THAT SOME GRC OFFICIALS MIGHT WELCOME FJHUMMING CLOSING DOWN HERE.

3. IF FJHUMMING IS TO BE CLOSED, PLEASE ADVISE WHAT CHANCE THERE IS THAT GRC MIGHT CONSTRUE CLOSING AS WITHDRAWAL
