1. MR. KELLEY, AMCOMLIB, WILL MEET ADMIRAL CONNOLLY AT HOTEL VIERJAHRESZEITEN AT 0900 29 MARCH. WILL PERSONALLY CONDUCT BRIEFING, BUT WILL HAVE TWO OR THREE HIS U.S. STAFF STANDING BY IN EVENT ADMIRAL WISHES INTERVIEW THEM. FORESEE LITTLE NEED FOR USE OF PSEUDO, SINCE MOST INDIGENOUS STAFF NOT WORKING SATURDAYS.

2. MR. HAZELHOFF, RFE, WILL MEET ADMIRAL AT HOTEL VIERJAHRESZEITEN 1300 29 MARCH, FOR LUNCH AND SUBSEQUENT BRIEFING. KEY MEMBERS U.S. STAFF WILL BE AVAILABLE IF ADMIRAL WISHES TALK WITH THEM. HAZELHOFF TENTATIVELY PLANS SMALL RECEPTION FOR ADMIRAL 1830 29 MARCH WITH KEY U.S. PERSONNEL IF ADMIRAL WISHES.

3. FOR FRAN: VIEW LIMITED TIME THIS PORTION ADMIRAL'S SCHEDULE, REQUEST YOU ADVISE US 25 MARCH FROM BONN AS TO ANY PARTICULAR ASPECT RADIOS WHICH OF PARTICULAR INTEREST ADMIRAL. IF TOUR FACILITIES DESIRED THIS WILL CUT DOWN ON SUBSTANTIVE BRIEFING.
