Frankfurt and Bonn Bases have recently addressed reference dispatches to Munich Base requesting our assistance in obtaining more copies of the Biographic Directory of the USSR which has been published by the Institute for the Study of the USSR.</p> <p>2. We have discussed this matter with our usual contact at PBCHORD and we have found out in answer to a specific query from Bonn that the Directory has not been published in German.</p> <p>3. With respect to filling the order of Frankfurt for five additional copies and that of Bonn for two more copies of the English edition, we have been advised that the Directory is being sold at \$16.00 per copy and that there is a great demand for the book at that price. Under these circumstances, the problem of obtaining seven copies of the Directory without payment becomes a somewhat difficult matter to explain to a number of unwitting people who would be involved in such a transaction.</p> <p>4. With this difficulty in mind we should like to ask Headquarters if they are in a position to furnish Frankfurt and Bonn with five and two copies respectively of the Directory. If Headquarters is not in a position to do this, then Munich Base could probably buy the books from the Institute and the cost could be T/A'd to the recipient Bases. Please advise how this matter should be handled.</p>
