<p>1. As a part of its overt function the New York Headquarters for FJHMMING recently asked <input type="checkbox"/> concerning his evacuation plans. He reported by mail that he had visited the Chief Consular Office at the Embassy who had advised him of the procedures. <input type="checkbox"/> states that it is his plan to move all dependents by commercial air transport to Tokyo immediately upon receipt of the Ambassador's first warning. Upon the second notice the remaining FJHMMING personnel would depart for Tokyo.</p> <p>2. <input type="checkbox"/> plans for operations and destruction of records are also based on the series of warnings. He states that upon receipt of the second notice he will turn over two weeks of operational tapes to STRAGPIPE together with a copy of all property records and sufficient funds to carry on the FJHMMING operation for at least a month. He would take with him the important files and destroy all remaining files of any consequence. <input type="checkbox"/> would await further instructions from New York in Tokyo.</p> <p>3. The New York office is replying that these plans have their approval and is also urging that at the first warning all personnel except one or at the most two in addition to <input type="checkbox"/> depart for Tokyo.</p> <p>4. Reference asked that the U. S. staff of FJHMMING be incorporated into your <input type="checkbox"/> current evacuation plans. Since we have had no reply to reference we assume that <input type="checkbox"/> is fully aware that he and the other non-indigenous personnel are incorporated into the <input type="checkbox"/> plans and that he will receive directions from you in time of emergency. This, of course, he could not report to his New York office in overt correspondence. Headquarters would appreciate having your confirmation that evacuation plans have been discussed with <input type="checkbox"/> and that he and his associates are included in your plans for KUBARK personnel.</p>		INDEXING CAN BE JUDGED BY QUALIFIED HQ.
