On behalf of TPFZELING we wish to express appreciation for putting in a good word with Greek authorities in connection with the interview project involving Greek repatriates which has been conducted by TPFZELING for some time and has recently been interrupted by adverse action on the part of the Greek authorities.</p> <p>2. The latest word we have received on this matter has been sent to you with ECMA 37435. Indications are that the project is back on the track after having been placed more or less under control of the KYP.</p> <p>3. We have noted with interest your comment in <input type="checkbox"/> 3198 that the Greek service makes extensive use of BOCALLUS material. In this connection we have just received copies of internal PACHORE correspondence which bears on this subject. For your information we are transmitting under separate cover a memorandum of 23 September 1958 written to the deputy head of BOCALLUS by <input type="checkbox"/>, KUBARK staffer assigned as assistant to <input type="checkbox"/> at TPLINGO.
