1. We are transmitting under separate cover CAM memorandum 12-59 dated 18 February 1959. In this memorandum [] records the circumstances of a complaint recently made by a new free-lance employee at TPLINGO. The complaint sets forth circumstances of a beating which the employee alleges was inflicted upon him by two individuals whom he accuses of being engaged in espionage activities for the Soviets.

2. After consultation with Adrian R. Belenko, [] referred the employee to the police. In accordance with [] request we have run traces at Munich Base on the individuals accused of being spies for the Soviets and we find that the only information we have has to do with a postcard which one of the individuals received from a friend of his who was vacationing in the CSR at the time. According to our records the friend appears to be pro-communist.

I was claimed to be beaten up by ~~SUBJECT~~ ~~SUBJECT~~

On 13 February 1959, the above individual came to my office and complained regarding the fact that he had been beaten up at his former residence in the Kaulbachstrasse 68a/II. GORCHAKOV advised that he resides there in the home of ~~MISS GUDRUN VOSS~~. In addition to VOSS and GORCHAKOV, one Karl ROSSBACH also resides at this address.

GORCHAKOV told a long involved story (which incidentally he has told several other individuals at AmConLib) regarding the fact that he had had an affair with Miss VOSS and later became involved with both ROSSBACH and VOSS who had beaten him up. Although it is my opinion that this involves a purely personal affair, GORCHAKOV intimated that both VOSS and ROSSBACH were engaged in espionage activities for the Soviets. He pointed out that ROSSBACH is a photographer and stated that both ROSSBACH and VOSS had kept him "under pressure" at the apartment for over a year when he would have preferred to move out.

Following his beating at the hands of ROSSBACH and VOSS, GORCHAKOV did move out and is presently residing at the Prinz Ludwig Pension in Hohenzollernstr. 25.

I discussed this matter with Paul MORLLER and subsequently referred GORCHAKOV both to the police and to Dr. SOHN, the Steuerberater, presently in the employ of the Committee. Dr. SOHN advised GORCHAKOV that he would handle his case in court against VOSS and ROSSBACH for a fee of DM 75.--. GORCHAKOV indicated that he felt this fee was too high and that he was going to rely on the local authorities in order to press criminal complaint charges against ROSSBACH and VOSS and in order to regain his personal possessions which are still in the apartment. In this connection he made a request that I intercede for him in order that he might receive an advance on his salary. He requested an advance of DM 1000.--.

I discussed the above matter with Jean LEGACH making no personal recommendation for or against the advance to GORCHAKOV. LEGACH indicated that GORCHAKOV had received a DM 500.-- advance against his February salary and that it would be against Committee policy to advance him any more funds.

It is requested that you check your local sources regarding a Mrs. or Miss Gudrun VOSS and Karl ROSSBACH. No additional ~~known~~ pertinent background information is available regarding them other than the fact that they reside presently in the Kaulbachstrasse 68a/II.

On 28 July 1954 Karl Rossbach received a postcard from Alois ORTNER who was vacationing in the CSR at the time. ORTNER appears to be pro-communist.
