REFERENCE(S)	<p>1. A short time ago [ ] received from the AMCONGEN Security Officer a brief note which cast some suspicion on the political affiliations of a long-time employee of TPLINGO. On 12 January 1959 in CAM Memo 4-59 [ ] asked Munich Base to check on the alleged former wife of the suspect TPLINGO employee. The present husband of this woman, according to the note [ ] received from the AMCONGEN Security Officer, is supposed to be a Communist Party member. He is presently living in a town in West Germany close to the Soviet Zone border. His wife who also works at TPLINGO visits him frequently.</p> <p>2. A check at Munich Base revealed no traces on either the woman employed at TPLINGO or on her husband. The woman, of course, had been traced prior to her employment in October 1955. Results at this time were also negative.</p> <p>3. [ ] himself has made an investigation of the allegations contained in the note he received from the AMCONGEN Security Officer and he has been able to determine that the long-standing employee of TPLINGO who has been cast in suspicion by the note was never married to the woman who works in his office at TPLINGO and whose present husband is allegedly a member of the Communist Party. Furthermore, [ ] has determined from his own investigation that this allegation against the present husband is also unproven and is likely false.</p> <p>4. We are forwarding under separate cover copy of the note [ ] received from the AMCONGEN Security Officer, as well as a copy of CAM Memo 4-59.
