- Reference A indicates the possibility of a disturbing breach of operational security in connection with TPLINGO's relationship with CAREZONE.
- The fact that location and Krawec's opportunity to interview him constituted classified information raises the question: How did Krawec's intended visit to CAREZONE become known "among his colleagues and acquaintances" in Munich of whom DOVHAL was certainly an unauthorized person?
- Again, if Krawec "did not know for certain that was at CAREZONE," what was the purpose of his trip (see Ref B)? Would he not have been better advised to have put DOVHAL off definitely by telling him that he had no means of delivering his letter?
- Instead of the formula outlined in the second sentence of para 2 of Ref A, Krawec should be instructed to tell DOVHAL, if he has to mention it at all, that he left the letter with "friends" for possible eventual delivery, and not to say he left it with GDUKKE authorities.
- It is requested that be briefed on references and that a full explanation be forwarded to Headquarters, together with a statement of steps taken to prevent a recurrence.
