Reference A requested derogatory field traces only on an American citizen named Nancy Erickson, an applicant for a secretarial position with PBEHED. <input type="checkbox"/> noted that he had granted a PPA for such use because her father was a Foreign Service Officer presently assigned as Security Officer at the American Consulate General, Munich.</p> <p>2. Reference C sets forth the KUSODA-approved procedures under which the PBEHED security officer is authorized to issue PPA's for American citizens who are job applicants to the project. These procedures provide that such a PPA may be issued only after receipt of the results of KUSODA (Headquarters) name checks on the applicant. No exceptions are authorized. Therefore, the usual 24-hour KUSODA check was initiated on Miss Erickson and the results forwarded per reference B.</p> <p>3. While we realize why it seemed logical to <input type="checkbox"/> to deviate from established procedure in this case, we must request that the prescribed requirements be observed in the future.</p>
