1. Returned herewith receipted pink shipping vouchers in duplicate covering shipments 17860-A, 17860-B, 17860-C, 17860-D, 17860E, 17860F, 17860G, 17860H, 17860-I, 17910-A, 17950-A, 17950-B, 17950-C, 17950-F, and 18000-A.

2. Shipment 17950-B was short two cases numbered 127 and 129. Shipment 17950-C was short two cases marked 184 and 188. These items, two foreign language typewriters, one typewriter, non-portable, 26" capacity, and one adding machine, hand-operated, have not been located to date. The Transportation Supervisor, Bremen, has been notified (copy of letter attached) and all efforts to locate these missing items are being made here. Could you check at that end to determine if possibly they were not loaded. In event these items are found here, you will be notified.

3. We have received in error two cases, (no shipping documents) marked 17020-C, boxes 2 and 3. Upon uncrating these were found to contain spare parts kits for model 1947 Ford automobiles. Could you check the records to determine the correct addressee and notify us so that forwarding of this shipment can be made. A check is also being made with the Transportation Supervisor, Bremen, on this matter.

4. The following goldenrod copies have been received: 17950-D, 17950-E, 17950-G, 17950-H, 17905-A, 19230-A, 18230-B, and 18340-A. Pink copies have been received for 17950-E, 18230-A, and 18340-A. These shipments have not been received as of date.
