1. REF MADE TO 15 TRANSMISSION TOWERS NOW ERECTED AT GREENWOOD SITE. TOWER DIRECTIONAL PATTERN PERMITS BROADCASTING TO ALL MAJOR SATELLITE AREAS.
2. THESE TOWERS ORIGINALLY LOANED US BY ARMY SECURITY AGENCY WITH UNDERSTANDING WE WOULD REPLACE THEM WITH NEW ONES FROM STATES OR RETURN THEM WHEN OUR OWN ARRIVED IN THEATRE.
3. ASA NOW REQUESTS TOWERS BE RETURNED OR REPLACED NOT LATER THAN 1 APRIL.
4. IF PROSPECT OF USING GREENWOOD SITE FOR RADIO BROADCASTS REMAINS SAME AS WHEN E LEFT, HE RECOMMENDS DISMANTLING AND RETURN OF TOWERS TO ASA SOON AS POSSIBLE. IF TOWERS ARE TO REMAIN STANDING, REPLACEMENTS IN STATES SHOULD BE ORDERED IMMEDIATELY TO MEET 1 APRIL DELIVERY DEADLINE. SUGGEST DISCUSSING WITH E.
5. GREENWOOD HOUSE AND GENERAL AREA CAN BE INDEFINITELY RETAINED BY EDUCATOR FOR POSSIBLE FUTURE OPERATIONAL USE.
6. APPRECIATE EARLY DECISION ON TOWERS.
