1. BEGINNING PRODUCTION OF FOUR PAGE MIMEOGRAPH EDITION OF SZEBAD MAGYAR (*ALSO RCVD SZABAD MAGYAR) NEP (FRE HUNGARIAN PEOPLE). TITLE IS PLAY ON OFFICIAL COMMUNIST PAPER "FREE PEOPLE".
2. THIS IS SECOND EDITION OF SAME PAPER PREVIOUSLY PRINTED BY AND DISTRIBUTED IN BUDA.
3. PAPER PURPORTEDLY PUBLISHED BY NATIONAL COMMUNISTS RESISTING PRESENT COMMUNIST HUNGARIAN REGIME FOR SUBSERVIENCE TO MOSCOW AND PROSTITUTING HUNGARY AS COLONY OF SOVIET. GENERAL LINE IS TO ENCOURAGE SPLIT WITHIN COMMUNIST RANKS.
4. J'S TEAM HAS DEVELOPED LIST OF 1500 ADDRESSES IN HUNGARY. WILL MAIL FROM LINZ AND VIENNA. PAPER STATED NOW PUBLISHED OUTSIDE BUT WILL APPEAR LATER IN HUNGARY. THIS WE PLANNING TO DO WHEN CHANNELS DEVELOPED. PAPER REPRESENTS SMALL BUT NECESSARY START TOWARD HUNGARIAN PRODUCTION AND OPERATIONS. UNTIL PRINTING PLANT ESTABLISHED WILL CONTINUE TO USE MIMEOGRAPH OR ANY OTHER SAFE SUBSTITUTE FACILITIES. POUCHING COPIES AND SUMMARY. IF YOU NOT IN AGREEMENT ADVISE SOONEST SINCE WE PLAN MAILING WITHIN FIVE DAYS.
