SUBJECT: Terence G. Ruark, District Distribution Agent under MIBELLE Project

1. Reference is made to the above described cable requesting initiation of a home office investigation of the above subject whom we wish to employ as a District Distribution Agent under the MIBELLE Project--a proposed distribution net operating within the general sphere of the EARPHONE program.

2. The following information is enclosed:

- A. An application and snap-shot submitted by the subject in duplicate.
- B. Memorandum from [], dated 17 May 1949, describing generally the duties and terms of employment proposed for the subject.

3. As indicated in []'s memorandum the subject, if cleared for employment will be engaged in the clandestine distribution of material produced by the editorial organization of the EARPHONE program. The proposed assignment is in accordance with the prior basic planning for EARPHONE and I am in agreement with the outline of duties and the recommended salary.

4. A field investigation of the subject as already been initiated and the results will be transmitted to you as soon as possible. In the meantime, it will be appreciated if you will proceed with your home office investigation on the basis of the information contained in this memo.

5. Because of his connection with KARL in an agent capacity, it is assumed that []'s organization will have the file on this subject.

1. Subject is being identified in my Personnel Memo # 56 of today. RM BELLE
2. Reference is made to my memoranda, subject , dated 2 and 16 May respectively.
3. Subject has been employed by KARL under the name CAPUT FOUR. I suggest that security clearance be based primarily on KARL's records. KARL's case officer has furnished me with some detailed information on subject from which I quote the following essential passages : " Subject is another former Abwehr officer who served under ~~SWARTHOOT~~ He is the son of a close friend of ~~THEY~~ and for years have been like uncle and nephew. In his work for us, subject has shown energy and some ability ... His maps, reports and surveys are well drawn, detailed and well thought-out. He is young enough to get around well and will be a good man for your work. Subject has a cover employment with some firm "
4. I recommend subject for employment as a district agent (of my memo of 16 May, as referred to in para 2 above) on a full-time basis, to be paid D-Mark 750 per month which are to cover both his salary - DM 400 - and his expenses for travel, operational entertainment and so forth. His employment is to begin on 1 June, by which date his employment by Karl will be terminated.
