SUBJECT: Lemuel E. NAPIER, District Distribution Agent under KMBELLE Project
REF : HEIDG-785 (Walter Kraushaar) JG-193

1. Reference is made to the above described cable requesting initiation of a home office investigation of the above subject whom we wish to employ as a District Distribution Agent under the KMBELLE project--a proposed distribution net operating within the general sphere of the EARPHONE program.

2. The following information is enclosed:

- A. An application and two snap-shots submitted by the subject.
- B. A memorandum from [] [], dated 17 May 1949 describing generally the duties and terms of employment proposed for the subject.

3. As indicated in [] []'s memorandum the subject, if cleared for employment will be engaged in the clandestine distribution of material produced by the editorial organization of the EARPHONE program. The proposed assignment is in accordance with the prior basic planning for EARPHONE and I am in agreement with the outline of duties and the recommended salary.

4. A field investigation of the subject has already been initiated and the results will be transmitted to you as soon as possible. In the meantime, it will be appreciated if you will proceed with your home office investigation on the basis of the information contained in this memo.

5. Because of his connection with KARL in an agent capacity, it is assumed that [] []'s organization will have the file on this subject.

KMBELLE project.

1. Reference is made to my memoranda, subject KMBELLE, dated 2 and 16 May respectively.

2. Subject has been employed by KARL as an agent in the chain operated by George G. Swarthout. I suggest that security clearance be based primarily on KARL's records. Karl's case officer has furnished me with some detailed information on subject from which I quote the following essential passages:

"This agent was recruited by Swarthout around February 1948...He had also been a former Abwehr man, a subordinate of Swarthout in the Balkans...Recently he has been surveying various border areas for us, with a view to developing border-crossing operations. In this connection he has surveyed the US Zone/Sovzone border from around Hersfeld south to Mellrichstadt..."

3. I recommend subject for employment as a district agent on a full-time basis, to be paid 750 D.M. per month which would cover both his salary—400. D.M.—and his expenses for travel, operational entertainment and the like. His employment is to begin on 1 June, by which date his employment by KARL will be terminated.
