1. Reference is made to the above described cable requesting initiation of a home office investigation of the above subject whom we wish to employ as Chief Agent under the KIMBELLE Project--a proposed distribution net operating within the general sphere of the EARPHONE program.

2. The following information is enclosed:

- A. Application and snap-shot, submitted by the subject in duplicate.
- B. Memorandum from , dated 2 May 1949 describing generally the duties and terms of employment proposed for the subject.

3. As indicated in 's memorandum the subject, if cleared for employment will be engaged in the clandestine distribution of material produced by the editorial organization of the EARPHONE program. The proposed assignment is in accordance with the prior basic planning for EARPHONE and I am in agreement with the outline of duties and the recommended salary.

4. A field investigation of the subject has already been initiated and the results will be transmitted to you as soon as possible. In the meantime, it will be appreciated if you will proceed with your home office investigation on the basis of the information contained in this memo.

5. Because of his connection with EARL in an agent capacity, it is assumed that 's organization will have the file on this subject.
