SUBJECT: Data Sheets for Indigenous Service Personnel
REF :

1. Attached herewith is the personnel roster for the month of May of the indigenous service personnel employed by the Edict and Educator Projects, whose salaries are paid from Military Community or organizational funds as indicated on the roster.

2. The LCAISLE Project of EDUCATOR employed the services of seven personnel during the month of May. For reasons of security, it was considered more advisable to transport this group intact from the Austrian Theatre. Prior to their entry into this Theatre, these individuals were cleared by the CIC and Austrian Police regarding Communistic tendencies and criminal records. Background investigations are in progress on all these individuals.

3. Margaret Erbsenbacher resigned for personal reasons and was replaced by Elizabeth Baron. Efforts were underway to have Erbsenbacher removed by the Military Government because of past activities with the Communist Party.

4. The Military Post requested that we conform to a recent EUCOM directive reducing the allotment of indigenous personnel assigned to the U.S. Occupation forces. As a result, Anita Schleewis was released from employment with the EDICT Project.

5. Previously, it was considered advisable to find a replacement for Alfred Schubert, Greenwood guard, who requested release to take advantage of a position of more permanent status. Since that time, however, it has been decided to protect
