SUBJECT: Basic Unit Designation and Letter of Requisitioning Authority
for EDUCATOR and EDICT.

REF : - MGW-A-33

1. With reference to dispatch MGW-A-33, dated 2 January 1949, the basic unit designation discussed therein has now been established as "Administrative Statistics Unit" and there is enclosed a letter of authorization addressed to the commanding officers of the Frankfurt and Heidelberg areas which, being issued in the name of this new unit designation, will enable us to obtain what we feel to be all necessary services, supplies and other forms of operational support from the Army. The issuance of this letter has been confined to the Frankfurt Military Post and the Heidelberg Military Post because these are the only two areas in which we are presently established. Similar letters can be issued by the Adjutant General's Office at any time to the commanding officer of other posts in Germany in which we may later become established.

2. As pointed out in paragraph 7 of MGW-A-33, this new basic unit designation, "Administrative Statistics Unit", will not necessarily be used by us as a cover name. It is primarily an administrative designation for obtaining the issuance of the enclosed letter of authorization. If it is deemed advisable later, we can of course adopt this unit designation as a cover name for our central administrative activities under the EDICT Project. In the meantime, pending the completion of various cover arrangements now under consideration, we are continuing to use as a cover designation ~~DWA~~^{PRESENTLY} established one, "Special Technical Unit 7989".

3. It is believed that this broader letter of authorization will materially assist us in obtaining various types of administrative support from the command in this theatre and that it is a definite improvement over the restricted and somewhat contradictory letter
