1. Family Background

Alfred SCHUBERT is the eldest of three children of the carpenter Alfred Schubert and his wife Anna Schubert-Geissler. The parents are still living in Bergesgruen/Czechoslovakia but intend to come to Germany as soon as possible. Listed reference Karl Geissler, a uncle of the applicant, living at Stuttgart Boehelmerstrasse 42, was visited and confirmed the applicant's statements. He said furthermore that the applicant's father is a member of the social democratic party since long before the Germans came to Czechoslovakia in 1938. For his membership he was punished by the Germans and was forced to leave the Board of Forest where he was employed as a forest keeper. His affiliation with the social democrates was also the reason that he could stay in Czechoslovakia in 1945. The applicant's brother is Alois Schubert, lives at Stuttgart-Bad Cannstatt, 30 Laemlehalde, and is employed as a clerk with an office there. The sister Irma Hellinger-Schubert is married to the police man Wilhelm Hellinger and lives at Stuttgart-Waiblingen. According to the references and police files at each town, the Schubert's are well regarded people.

2. Birth

The applicant is born on 2 July 1920 at Coehren/Czechoslovakia, according to the birth records at the Town Hall, Stuttgart. As all refugees from Czechoslovakia he is stateless.

3. Education

According to the applicant's course of life at the files with the Stuttgart Police, he attended 6 years the elementary school and 2 years the secondary highschool. All references stated that the applicant is well educated and well bred.

4. Employment

The applicant was employed with the Board of Forest at Reichenberg/Czechoslovakia from August 1935 until 1938 and was released there for his sympathizing with the social democratic party. From 7 Jan. 1939 to 3 April 1939 he was working with the Office of Forest at Oberleutendorf and was ordered to the army in April 1939. His last rank was Sgt. On 3 July 1946 he was released from the American prison-camp in Harburg and came to Stuttgart-Bad Cannstatt where he is living since.

Since 1 October 1946 he is as a guard with the Police Department at Stuttgart and as chief-guard he was transferred to the Military Government on 7 September 1946.

5. References

Listed Police Inspector SHRECK stated that he knew the applicant only by name and cannot say anything about his character. Karl PROSS, policeman, 56 years old and living at Stuttgart 20 Tannenstrasse, stated that he was working together with the applicant as a guard. He described him as conscientious and efficient. Schubert is well educated and has a good character. He was well liked by all of the other policeman. Reference Pross stated that he noticed during

all conversations with the applicant that he is a social democrat and an anti-communist.

Hans BERROTH, 35 years old, living at Stuttgart, 1 Hausmannstrasse, worked together with the applicant from December 1947 until Jan. 31, 1948 and confirmed the statements of Ehrbeck.

Albert EHMANN, a 39 years old policeman, lives at Stuttgart-Degerloch, and described the applicant as throughout dependable and conscientious. His character is good and his general knowledge refers back to a good education. As far as reference Ehmman knew, the applicant is anti-communist.

Reference Karl GEISLER, explained that the applicant comes from a well regarded family, that he has a good character and is industrious and honest.

Frau Emilie BUBECK, living at Stuttgart-Fellbach 10 Traubenstrasse, stated that the applicant is living in her house since August 1946. She described him as a very nice and orderly young man, with whom she never had any trouble. She has seen him last in March 1949 and he told her that he is employed near Heidelberg.

6. Credit

It could not be obtained that the applicant has a bank account but it was learned from references that he is a saving, modest young man.

7. Police

The applicant was living in Goehren and Oberleutendorf/Czechoslovakia from birth on until he had to join the army in 1939. Since 14 Aug. 1946 he is listed as an inhabitant of Stuttgart-Fellbach and lives there at No. 10 Traubenstrasse. Nothing detrimental is known about him at the Police Station at Fellbach.

8. Summary

Alfred SCHUBERT was described by all references as a well regarded young man. He has good recommendations from his former superior at the Stuttgart Police Department, where he was employed as a chief guard. It was emphasized by all references that the applicant is industrious and conscientious and that he is an anti-communist.
