WE DO NOT CONSIDER PRESENT INSTRUCTIONS TO SHOULD PRECLUDE ~~EDUCATOR-EDICT~~ KEEPING VIEN FULLY INFORMED THROUGH HEID AND KARL AS TO THE MOVEMENTS OF ITS PERSONNEL WITHIN VIEN'S AREA AND WE BELIEVE THAT THIS IS THE ONLY PRACTICAL MEANS OF MAINTAINING SECURITY, FAVORABLE RELATIONS WITH U.S. AUTHORITIES, AND AVOIDING OCCURRENCES SIMILAR TO THE REFERENCE ONE.

2. WE FULLY AGREE THAT UNTIL AUSTRIAN OPERATION PLANS ARE COMPLETED AND APPROVED AND GENERAL KEYES IS PROPERLY INFORMED OF WASHG CHARTER AND PROGRAM, SHOULD BE KEPT INFORMED.

3. SHOULD TAKE CARE TO USE APPROPRIATE PSEUDONYMS IN FUTURE COMMUNICATIONS.
