The second report, R-131-49 dated 24 Feb. 1949, was compiled by the Office of the Military Attache from information furnished by IVANOVICI and is entitled "Rumanian Resistance in Foreign Countries." The report is summarized by the writer as follows: "Confidential source came to this office to outline his Rumanian resistance network of which he was a special representative of General Nicolae RADESCU, the Chief."

RADESCU believes that I was scheming for a moment with the "mandatorie" (those receiving mandates), General RADESCU is sadly mistaken. The hate and the dislike which he has for me arises because I told him sincerely my convictions which have proven to be true. I brought him from Cyprus to France at a time when THOREZ was vice president, and I kept him and his secretary at my home. Upon three other occasions I showed him the same kindness of letting him stay at my home; that is understood of course that it was his wish. I transformed my house into a political club. The three months that he stayed at my house, he disrupted my life to such an extent that I was forced to borrow money from DIMI and CIUREA. I have not asked General RADESCU, and I will not ask him, for anything. This game seems very immoral to me, what is more he has found low and imbecilic elements to support him in his activities of dissension among the resistance movement in exile, such as LUPAIA, LEONTIU, TELU, CHIRNOAGA, MAFTEI etc, to which can be added the Legion --today he is sending his instructions through IVANOVICI "who has a new mandate" for the Continent.

I would like to ask you, Mr. Minister, that when General RADESCU raises some objection in regard to me, do not argue with him because I refuse, and please believe me because I have my reasons, and I will not accept any concessions from General RADESCU. I will not accept to be on the Committee headed by General RADESCU because he considers me as a bad patriot, spy, and a hindrance. The "true collaborators and devoted people" which he is looking for he has found in another place and in another "camp."
