SUBJECT: Further Data Concerning Letter from General  
Radescu.

1. Reference is made to my memorandum of 27 January 1953 in which I forwarded you a copy of a memorandum from General Radescu to Mr. J. Anthony Panuch, which was transmitted to us by the Fund.

2. On 4 February 1953, Mr. Panuch called on one of the officials of the Fund. He stated that he was representing General Radescu in this matter, presumably in his capacity as an attorney, and that he intended to pursue it until the funds in question were placed at the disposal of the Romanian emigration as a whole.

3. Mr. Panuch indicated his intention to call on persons in this agency and the Department of State. The Fund official made it clear to Mr. Panuch that if he should do so it would be entirely on his own initiative, and that he could not in any way presume to speak for the Fund in any such representation.
