1. The German Mission files contain no record of Subject, but give the following possible traces on individuals given as references by Subject:

- a. ABAY, Koloman
Possibly identical with Kalman ABAY, born 4 January 1899, Pecs, Hungary. He is connected with another American agency. MOLA-2655, 25 April 1951
- b. RAJNOCZY, Anthony
Born 12 February 1912; Hungarian nationality; Vogellstr. 39, Munich. Dropped without prejudice 9 April 1951. MCHA-11267, 18 July 1951

2. The police and neighborhood investigation revealed the following:

a. Points 3 and 20b of Subject's Form IX have been verified. Subject currently has Displaced Person's status. He escaped from Budapest, Hungary, when the Soviets invaded that city, and he was forced to leave his wife and two sons in Hungary (F-5). One of his sons is reportedly imprisoned by the communist government in Hungary (F-6). Subject lived at 32 Schleissheimerstr., Munich, prior to 1948, and from March 1948 to April 1952 he resided at Siegfriedstr. 5/1, Munich 23. Source: Einwohnermeldeamt (B-2), except as noted.

b. Subject reportedly studied psychology and earned a Doctor's degree in Hungary (F-6).

c. Subject served as a police official in Budapest until the end of 1944 (F-3). He was employed in the U.S. Zone of Germany as a cook and a janitor for the U.S. Army for some time, and he currently is employed as a reporter for the Hungarian newspaper "Hungraia"; this newspaper is published in Munich. Source: Police records (B-2), except as noted.

d. There is no information available concerning Subject's military career other than that he reportedly held the rank of captain in the Hungarian Army (F-6).

e. Subject is reportedly a strong anti-communist and sympathizer of the democratic way of life (F-6). He is a member of the Hungarian National Committee, and the "Association of the Free Press in Germany" (F-3).

f. Subject has been described as having a quiet, balanced character. There is no derogatory information available concerning Subject (F-6).

g. One Dr. FNU Herp, residing at 2A Feilitz Str., Munich, is a close friend and associate of Subject (F-3).

h. Subject has no political or criminal police record. Source: Official Police Records (B-2).
