1. Forwarded herewith in one copy each for EE and VOB are the following two reports giving additional biographic and background data on Rezső PALASTHY. The reports were written by PALASTHY himself upon instructions from [ ]:

a. Angaben ueber meines Lebens in der Emigration von November 1949 Heute, 17 pages. This is PALASTHY's detailed report of his life activities in the emigration after 1949. Of particular significance PALASTHY's previous intelligence contacts with Feder (?), RICH OCK and with Antal RADNOCZY, which were reported in EAO, Part II, 4-4913. PALASTHY will be questioned in greater detail on these contacts. Also of particular interest is PALASTHY's close contact with [ ] MIK from 1949 to 1953 and his continued personal contact with Dr. [ ] HANRA, editor of the MIK paper [ ]

b. Moeglich bekannte Angaben, Tatsachen und Vermutungen im Zusammenhang mit meiner Person bei der AVH, 3 pages. This is an attempt at writing up all the information on PALASTHY which is known to me from the AVH, i.e. at reconstructing the AVH file on him. Dymond had hoped that this report would give some clue as to what information the AVH has which caused them to believe PALASTHY to be recruitable, but the report did not help in this respect. The question why the AVH believed PALASTHY susceptible to recruitment remains unanswered. The report is mostly a re-hash of information previously submitted in EASA-4677 and EASA-4809.
