1. RE PARA 6 REF: ON BASIS DIR 14700 (OUT 97554) WE AUTHORIZED CAMBISTA 2 PROCEED CADRE SCHOOL ONLY FOLLOWING EXTENT:
 - A. INVESTIGATE CAMBISTA BELGIUM IN LINE WITH EGOW 154.
 - B. ESTIMATE INITIAL COST OF TRAVEL, REAL ESTATE, RECRUITMENT INSTRUCTORS AND STUDENTS, OTHER ADMIN DETAILS.
2. FEEL ABOVE STEPS BOTH REASONABLE AND SECURE VIEW CAMBISTA 1 POSITION IN BELGIUM. CAMBISTA 2 HAS PREVIOUSLY SUBMITTED PRELIMINARY CURRICULUM AND BUDGET (SEE AGMA 10483) BUT WE PREFER LEAVE PREPARATION DETAILED CURRICULUM TO CADRE DIRECTOR.
3. VIEW REF REQUEST HQ STATEMENT RE FOLLOWING:
 - A. LIMITS COMMITMENTS TO BE MADE ANY FUTURE DISCUSSION CAMBISTA 1 RE CADRE, WEST AND ALL OTHER ASPECTS AEQUOR PROJECT.
 - B. AUTHORITY CONTINUE OR INSTRUCTIONS DISCONTINUE STEPS PARA 1 ABOVE.
 - C. FINANCIAL AUTHORITY UNDER WHICH WE CAN OPERATE. PRESENT OBLIGATIONS CAMBISTA 1 ARE AS OUTLINED IN AGMA 10293, AS AMENDED PARA 3 D 2, EGMA 0789, WITH EXCEPTION NO ADDITIONAL FUNDS PROVIDED CAMBISTA 2 FOR RECRUITMENT PURPOSES. ALSO REQUIRE FUNDS CONDUCT TRAINING PROJECT WITH INDEPENDENTLY RECRUITED AEQUOR CANDIDATES. LATTER INVOLVES EMPLOYMENT HOUSEKEEPER, TRAINEE SALARIES, ROUTINE TRAINING EXPENDITURES, ETC.
