1. SUBJECT RAJAKOVIC ACCOMPANIED BY WELL KNOWN COMMUNIST FRONT LAWYER JOHANN DOSTAL APPEARED VIENNA COURTHOUSE 17 APRIL "TO CLARIFY HIS STATUS" APPARENTLY UNDER IMPRESSION NO AUSTRIAN CHARGES AGAINST HIM.

2. HE WAS ARRESTED AND JAILED FOR INVESTIGATIVE CUSTODY UNDER CHARGES COMPLICITY OF MURDER ON BASIS EVIDENCE WHICH ALLEGEDLY OBTAINED BY AUSTRIAN AUTHORITIES DURING EASTER HOLIDAYS.

3. ACCORDING MASS CIRCULATION VIENNA KURIER, SUBJECT'S BUSINESS CONTACTS INCLUDED DEUTSCHE STAHL UND METALL AND DIA ELEKTROTECHNIK IN EAST BERLIN, MEDIMPEX IN BUDAPEST, URSS MACHINE TRADE FIRM IN MOSCOW, FERROMET AND SEZ COMMERCIALE IN PRAGUE.

4. AUSTRIAN PAPERS GIVING EXTENSIVE PUBLICITY.
