1. SUBJECT IS COLONEL ALFONS REBANE, DPOB 27 JUNE 1908, VALGA, ESTONIA. PROFESSIONAL ARMY OFFICER IN PRE-WORLD WAR TWO ESTONIAN ARMY, 1941 TO 1945 SERVED GERMAN ARMY AS COMMANDER SEVERAL ESTONIAN UNITS IN COMBAT WITH SOVIETS. AT CLOSE OF WAR WAS COMMANDER XX 46 REGT OF 20TH WAFEN SS DIVISION, COMMANDED DIVISION BRIEFLY WHEN GERMAN GENERAL AUGSBERGER KILLED IN ACTION.
