1. IN CONVERSATION 8 MARCH WITH INGRAM AND COL BROWN, LOEWER AND BRAILLARD REFUSED TURN OVER DOCUMENTS FOR LESS THAN \$10,000. HOWEVER DURING LATER INTERROGATION, PROVIDED INFO ANALYSED BY BROWN AND [] AS FOLLOWS:

A. BROWN [] BELIEF CONFIRMED THAT MARC BLOCH, GENEVA RESPONSIBLE SALE 11 MILLIONS SWISS FRANCS VALUE KUGELFISHER BEARINGS TO CHINA IMPORT AND EXPORT OF EAST BERLIN WITH FINANCIAL BACKING AND ACTIVE SUPPORT UNION BANK OF SWITZERLAND, FIRST HANDLED BY GENEVA BRANCH BUT LATER TAKEN OVER BY MAIN OFFICE ZURICH. VALUE THAT PORTION ORDER ALREADY DELIVERED BY KUGELFISHER TO PALLAS OIL AND TRADING, LONDON AND STILL HELD IN UK IS 4 MILLION SWISS FRANCS. KUGELFISHER RECEIVED PAYMENT 2,500,000 SWISS FRANCS FACTORY PRICE FROM UNION BANK EARLY DEC 53.
