 Gundrunstr 5, or Frankfurt/M., Friedlebenstr 36, W. Germany

Subject joined the NSDAP in September 1939, was an Oberregierungsrat in the Prussian Ministry of State and Press Officer for Hermann Goering. After 1945 and until the beginning of World War II he was Chief of the Press Office in the German Ministry of Economics. On 29 July 1946 he was released as a Prisoner of War (American) whereupon he took up residence at the Bad Toeltz address. In 1950 he became editor of the weekly publication "Fortschritt" in Essen-Warthen, Völberter Strasse 8. The BFV suspects that Subject is currently engaged in intelligence activity. It bases this surmise on the multiplicity of foreign contacts (Morocco, Austria, Turkey and East Germany). Subject maintains his political activity in connection with the Eichmann case, and his attempts to found a Welfare Organization for Algerian refugees.

2. The BFV requests information as to whether we may be in operational contact with Subject. They have further indicated that investigations are in progress that may lead to taking executive action, therefore they would appreciate an early reply. If no information is available, a negative reply is requested.

- 3. Bonn Base files contain no identifiable traces on Subject.
- 4. CO 513th MI Group, and OSI have also been queried.
